Information about your request

The protection of your personal data is very important to AUDI AG. In order to process your request quickly, we require further information about you and your request. We will search for your data on the basis of the information you provide in this GDPR request form. Please note that we must first identify you unambiguously. Your first name, last name, postal address and other information about your data subject group are required fields. Information about your telephone number and email address help us to identify you unambiguously. To ensure better readability of the content we will not use gender-specific terms.

AUDI AG will answer your request within the statutory time frame. In the meantime, we kindly ask you not to inquire about the status of your request. Please send us additional documents (e.g. photocopies of your ID papers) only if we ask you for them. If you are inquiring not for yourself but for someone else, we need a written power of attorney from the data subject as well as a photocopy of the ID card of the person granted the power of attorney. This must show the following: First and last name, address and validity date. All other information (including the photo) may be blacked out or rendered illegible. Alternatively, you can submit a photocopy of your passport with these details in conjunction with a valid registration certificate. Please note that the copy of your ID card/passport must be unambiguous and permanently recognizable as a copy (e.g. a black-and-white photocopy marked "Copy").

By signing the consent declaration on the first page of this request form, you consent to AUDI AG processing the data on the sent photocopy of your ID card/passport, such as the first and last name, address, validity date and date of birth, in order to identify you in relation to your request. The copy of your ID document will be destroyed in a data protection-compliant manner as soon as your identity has been established. You can withdraw this consent declaration at any time with future effect. Please use the contact information listed below. However, if you withdraw your consent declaration before your identity has been confirmed, your request cannot be processed any further.

We can only give you information about your Audi if you were the vehicle's owner in the relevant period. Where necessary, we may require a confirmation from the vehicle's owner before we can provide information about your Audi.

If you request **information about stored data**, you will be provided with the data that AUDI AG has stored about you as a data subject. For data protection reasons, this information is sent by post only. We apologize for any inconvenience.

If you request **data portability**, you will receive the data that AUDI AG has stored on you as a data subject. This is supplied in a machine-readable format. This information as well as instructions on how to download your data will be sent to you by post only. We apologize for any inconvenience.

If you request the withdrawal of all consent declarations, you withdraw all consent declarations that you have made to AUDI AG. All personal data processed on the basis of your consent declaration is then immediately and permanently erased from AUDI AG systems unless we are entitled or obliged to process it further. One example of such an obligation is the fulfillment of an agreement to which the data subject is a party.

If you request **data erasure**, all your personal data will be immediately and permanently erased from AUDI AG systems unless we are entitled or obliged to process it further. One example of such an obligation is the fulfillment of an agreement to which the data subject is a party.

Please note that despite deletion of your personal data, you may still receive future advertising from AUDI AG, for example in the case of the use of external data. If you do not wish this, we will be happy to include you in our internal blacklist for direct marketing. Please note this on page 1.

In the event of an **objection to processing for direct marketing**, AUDI AG will permanently store your contact data (name and address) in an internal blacklist for direct marketing. If you have given AUDI AG consent for advertising measures, this remains effective, unless you note on page 1 a revocation of your declaration of consent.

If you request **data rectification**, we make the desired changes on all our systems. We then confirm this by post.

If you request **restricted processing**, we will block your personal data in accordance with the statutory requirements. We then confirm this by post.

AUDI AG will process your request in the system in which we have already saved your indicated relationship. In the interest of a clearer flow of information in the case of a request for stored data, if you have multiple relationships with us, you will receive separate confirmation notifications for each indicated relationship. The documents will be sent together in one letter.

Please note that your requests relate exclusively to AUDI AG. Third parties, for example your Audi partner, may also have personal data about you. If you wish to withdraw any declarations of consent vis-à-vis third parties you must do it directly with them.

Data protection notice

The data you provide on the GDPR request form, as well as any information you provide together with the form, is processed by AUDI AG exclusively for fulfilling your request. Of course, with regard to processing your personal data within the framework of your request, you also have the relevant data protection rights to information, rectification, erasure and restriction. They are not stored, but are destroyed immediately once your request has been entered (see the left-hand column regarding the handling of any photocopies of ID papers that you send us). Do not forget to include any required powers of attorney.

Please send us the documents within 30 days. If not, we cannot process your request and will close the case.
