Life cycle assessment Audi A6 Avant 45 TFSI quattro S tronic*

AUDI AG prepares a detailed life cycle assessment for new vehicle models at the start of production.

In the following, the Audi A6 Avant 45 TFSI quattro S tronic* with the German standard equipment without additional optional equipment is considered.

The methodology

The life cycle assessment (LCA) analyzes the environmental impact of a product throughout its life cycle (cradle-to-grave, see Figure 1). In a life cycle assessment for an AUDI AG vehicle, this is broken down into the following phases:

Within the life cycle assessment on hand, only the ecological impact category of greenhouse gas potential is quantitatively assessed. Further explanations can be found below.

• Production:

Manufacture of the components (from the raw material to the finished component) and production of the vehicle model.

When preparing the life cycle assessment, AUDI AG follows the procedure standardized in the international series of standards ISO 14040 ff.

• Usage:


Use of a vehicle model based on a predefined driving profile (WLTP) with a mileage of 200,000 km including upstream processes from the fuel or energy supply.

The following premises were used as a basis for preparing the life cycle assessment:

- Production year 2018, model year 2021
- Material data and component parts list of the examined vehicle model
- Combined fuel consumption according to WLTP in 2020
- 200,000 km mileage in the use phase
- Testing and validation by independent experts (TÜV NORD CERT GmbH)

The life cycle assessment software GaBi version 9.5.2.49 was used.

• **Recycling** at the end of the product life.

Life cycle assessment Audi A6 Avant 45 TFSI quattro S tronic*

The results - global warming potential over the entire life cycle

The global warming potential (GWP) describes the emissions of greenhouse gases that lead to an increase in the heat absorption of solar radiation in the atmosphere and thus can contribute to an increase in the global average temperature. The reference substance for the global warming potential is carbon dioxide (CO_2), to which all other active substances (e.g. methane (CO_4), nitrous oxide (CO_4), sulfur hexafluoride (CO_4), volatile organic compounds (CO_4) are related (CO_4) equivalents - CO_4 -eq.).

The Audi A6 Avant 45 TFSI quattro S tronic* causes approx. $53.2 \text{ t } \text{CO}_2\text{-eq}$. greenhouse gas emissions over its entire life cycle. In the production phase, the greenhouse gas emissions of the Audi A6 Avant 45 TFSI quattro S tronic* are around 8.4 t CO₂-eq. and 0.9 t CO₂-eq. are generated in logistics. In the use phase of the Audi A6 Avant 45 TFSI quattro S tronic*, 8.0 t CO₂-eq. account for fuel provision, as well as 35.5 t CO₂-eq. for driving emissions, which in total corresponds to almost 80 % of the total greenhouse gas emissions over the life cycle. The maintenance generates 0.4 t CO₂-eq. 0.03 t of CO₂-eq. are generated during recycling.




Figure 2: Global warming potential of the Audi A6 Avant 45 TFSI quattro S tronic* over the entire life cycle

Evidence of the rule-compliant application of DIN EN ISO 14040 was provided and a declaration of validity was issued.
